(hereinafter referred to as "Materials"), Materials of the XXIV International Scientific and Practical Conference of Young Scientists, Postgraduates and Students in Neryungri.

2. Objective

A. Copyright

1. Mastering the technique of knowledge testing is one of the important and difficult tasks a teacher can face.

4. The most important aspects revealed by the author in the article Example:

The author made an effort to determine the functions of feedback and control in teaching of foreign language to technical students. It is also important that E.V. Ryabtseva is talking about the necessity to change the role of the teacher in the process of English teaching to technical students, as a university teacher ceases to be the main source of information, a teacher should shape rather than manage the training process.
